Of our Consideration:

We have reviewed the following aspects of the Inventory of Greenhouse Gas Emissions for the 2022 period, of Concha y Toro.

Scope

Viña Concha y Toro has requested Deloitte a revision of their 2022 Inventory of Greenhouse Gas Emissions.

The mentioned report contemplates the estimation of the Corporate Carbon Footprint for *Viña Concha y Toro* and its subsidiary vineyards in Chile: *Viña Maipo, Viña Palo Alto, Viña Maycas* del *Limarí and Viña Canepa*, in addition to its subsidiaries *VCT* (national distributuin) and *Transporte Viconto* (transportation of wine) for the period between January 1st, 2022 and December 31st, 2022. The process was carried out considering the component analysis for its agricultural, oenological, packaging and distribution units, and operations in Chile, also developing a qualitative sustainability analysis of the Corporate Carbon Footprint.

The total number of emissions reported in Viña Concha y Toro's 2022 Corporate Carbon Footprint Report are presented in table 1.

Standards and Assurance Process

Our review of the Inventory of Greenhouse Gas Emissions, period 2022, was carried out in accordance with the guidelines of ISO 14064 Part 3. It should be noted that this verification does not constitute an audit and, therefore, we do not express an audit opinion about this statement.

The review process considered the official receipt of information, in addition to the verification activities carried out through analytical procedures and review tests described below:

- In meeting with persons in charge of the Inventory of Greenhouse Gas Emissions.
- Reception of the calculation Excel", folders with information and backups for each of the scopes.

- Review of the calculation's consistency and coherence for each of the scopes of the Inventory of Greenhouse Gas Emissions. These were verified by random samples, presenting the inconsistencies by emails.
- Request and receipt of evidence not covered by the Inventory of Greenhouse Gas Emissions 2022.
- Review of the coherence of information and data in the Greenhouse Gas Emissions Inventory, Viña Concha y Toro.

Conclusions

- No aspect han been revealed that would lead us to believe that the Inventory of Greenhouse Gas Emissions carried out by Concha y Toro has not been prepared in accordance with applicable international standars.
- All the inconsistencies found were clarified and improved, therefore, there is no evidence to suggest that the information provided about the 2022 Inventory of Greenhouse Gas Emissions contains significant errors.

Responsibilities of Viña Concha y Toro and Deloitte

- The preparation of the 2022 Inventory of Greenhouse Gas Emissions, as well as the content, is *Viña Concha y Toro'*s responsibility, who is also responsible for defining, adapting and maintaining the internal management and control systems to obtain the information.
- Our responsibility is to emit an independent report based on the applied procedures in our review.

- The conclusions emitted in this report are valid for *Viña Concha y Toro's* Greenhouse gases inventory Report 2022.
