We have performed a limited assurance engagement review of the key performance indicator associated to the Water footprint for the period from January 01 to December 31 of 2023, of the Concha y Toro S.A. (hereinafter "the Company"), in accordance with the Standards Water Footprint Network (hereinafter "Standars WFN").

## **Standards and Assurance Process**

Our responsibility is to express a limited assurance conclusion on the key performance indicator associated to Water footprint for the period ended as of December 2023 based on the procedures that we have performed and the evidence we have obtained. We conducted our limited assurance engagement in accordance with International Standard on Assurance Engagements Other than Audits or Reviews of Historical Financial Information (ISAE 3000), issued by the International Auditing and Assurance Standard Board (IAASB). This standard requires that we plan and perform this engagement to obtain limited assurance about whether the key performance indicator associated to Water footprint for the period ended as of December 2023 is free from material misstatement.

A limited assurance engagement involves performing procedures (primarily consisting of making inquiries of management and others within the entity, as appropriate, and applying analytical and other procedures) and evaluating the evidence obtained. The procedures also include assessing the suitability in the circumstances of the Company's use of the applicable criteria as the basis for the preparation of the key performance indicators associated to Water footprint for the period ended as of December 2023.

Our review included the following procedures:

- Meeting with the team that led the process of preparing the key performance indicator Water footprint.
- Obtained the spreadsheet with the key performance indicators as well as the information and evidence that support the key performance indicators.
- Review of key performance indicator consistency. These were verified through random samples, clarifying the differences, if any, with the Company's Management.

The details of the total declared in the Company's 2023 Water Footprint Report are presented below:
