We have performed a limited assurance review of the quantification of the greenhouse Gas Emissions Inventory of Viña Concha y Toro S.A, (hereinafter "the Company") and the winegrowing subsidiaries Concha y Toro, Viña Cono Sur, Trivento Bodegas y Viñedos and Bonterra Organic Estates, prepared in accordance with the provisions of the Greenhouse Gas Protocol Standards, (hereinafter "GHG Protocol") and Nch ISO-14.064 part 1, (hereinafter "ISO"), for the period from January 1st to December 31st, 2024.

Standards and verification processes

Our responsibility is to express a limited assurance conclusion on the review of the Greenhouse Gas Emissions Inventory quantification for the period between January 1, 2024, and December 31, 2024, prepared in accordance with the GHG Protocol Standard and ISO Standard, based on the procedures we have performed, and the evidence obtained, We conducted our limited assurance review in accordance with the International Standard on Assurance Engagements on Greenhouse Gas Statements (ISAE 3410), issued by the International Auditing and Assurance Standard Board (IAASB), That standard requires that we plan and perform our engagement to obtain limited assurance that the quantification of the Greenhouse Gas Emissions Inventory for the period between January 1, 2024 and December 31, 2024, in accordance with the GHG Protocol Standard and ISO Standard is free from material misstatement.

A limited assurance review involves performing procedures primarily (consisting of making inquiries of management and others within the entity, as appropriate, and applying analytical and other procedures) and evaluate the evidence obtained. The procedures also include the evaluation of the criteria and quantification of the Greenhouse Gas Emissions Inventory for the period between January 1, 2024 and December 31, 2024, in accordance with the GHG Protocol Standard and ISO Standard.

Our review includes the following procedures:

- Meetings with the professionals responsible for the preparation of the Greenhouse Gas Emissions Inventory,
- Receive the calculation Excel file, as well as folders containing information and evidence for each of the scopes,

- Analysis of the emission factors considered by company for calculating the 2024 carbon footprint,
- Review of the consistency of the calculations received for each scope of the Greenhouse Gas
 Emissions Inventory, these were reviewed through random sampling, and the differences, if
 any, were clarified with management.

The procedures performed in a limited assurance engagement vary in nature and timing from, and are less in extent than for, a reasonable assurance engagement, Consequently, the level of assurance obtained in a limited assurance engagement is substantially lower than the assurance that would have been obtained had a reasonable assurance engagement been performed.
